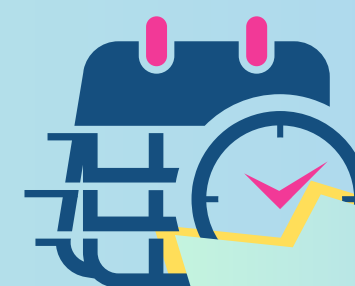

- The scientists are able to network with IP experts and assess the IP potential of their research findings.



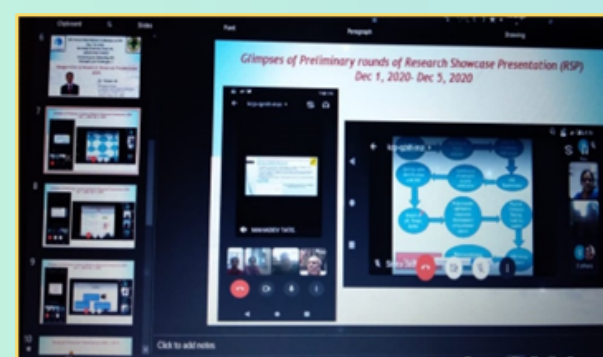

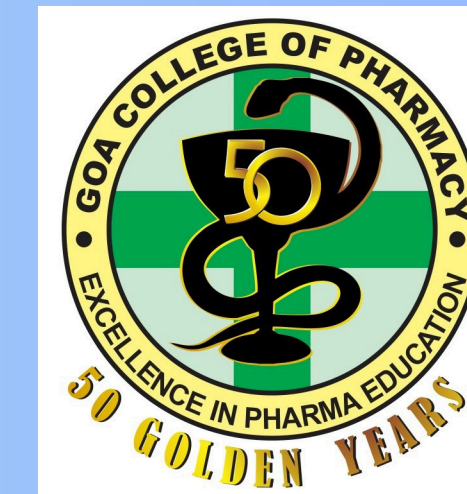
